As a Professional Certified Life Coach, I will not be counseling you in the capacity of a psychologist, therapist, or other mental health professional. If, at any time during our sessions, I feel that you require such a specialist, I will refer you.

If you're currently seeing a mental health professional, or begin to see one while we're working together, I'll need the Consent Form (below) signed by him or her.

If applicable, fill it out, sign it, and return it to me, and I'll mail it to him/her. Circle the number (1, 2, or 3) of the statement that best describes your situation:

1. I'm currently under the care of a mental health professional.
2. I'm planning on meeting with a mental health professional during the time of our coaching sessions.
3. I'm not currently under the care of, nor do I have plans to meet with, a mental health professional during the time of our coaching sessions.

Our coach-client relationship will be based on mutual trust, and I'll honor my obligation to you to maintain confidentiality; however, that confidentiality is not absolute. In the case that I, as your Coach, am court-ordered—or if I suspect or am informed of your self-harm, physical violence/abuse, abandonment, abduction, and/or your financial abuse, neglect, or exploitation of a minor or elderly adult, I'm ethically and morally obligated to report such cases to the proper authorities. And, with this newfound information, I reserve the right to terminate this agreement at my discretion at any time without a refund of your unused fees.
